

## Who?

All Girl Scouts registered with GSNENY for the 2022-2023 Membership Year are invited and encouraged to participate!



## What?

The Sweets & Treats Program is the first of only two Council Sponsored Product Sales programs. Participation in the Sweets & Treats and Cookie Programs is required to participate in any other money earning activities. Participation in Sweets & Treats is equivalent to selling one item or sending 18 unique emails to friends and family.



## When?

<b>October 5</b>	Program begins – online ordering opens and Girl Scouts may sell in-person.
<b>November 6</b>	Last day to take orders on the order card. All orders received in-person must be entered into the online system by the parent/caregiver.
<b>November 10</b>	Payment for any candy/nut paper order card sales is due to your troop at this time.
<b>November 10</b>	Last day to take online Girl Scout delivery orders. Last day for online orders for magazines and shipped nut and chocolate orders.
<b>November 30 - December 2</b>	Nut and chocolate items will be delivered to Service Unit sites. Check with your Troop Volunteer for location, date, and time to pick-up your candy/nut items for delivery.

## Where?

- Girl Scouts can sell in-person, online, or both!
- Processing is faster with online ordering.
- Girl Scouts can send emails to family and friends inviting them to order magazines, candy, and nuts!
- Family and friends can order any item offered and have it shipped directly to them with a shipping fee, or have items on the nut card delivered by the Girl Scout.
- Girl Scouts can track their progress throughout the sale and add emails to meet their goals quicker!





# Become a member of our S'mores Club!

To earn a spot in our S'mores Club, Girl Scouts must meet the following program requirements:

## Sweets & Treats Program

- Sell at least \$400 in total sales between Sweets (nuts and candy) and Treats (magazines) and send 18+ emails.
- Turn in all order forms, order cards, and money to Troop Sweets & Treat Manager or Troop Leader by the troop-established deadline date.

## Cookie Program

- Sell at least 350 boxes by the end of the initial sale or a minimum of 750 boxes by the end of the Cookie Program.
- Participate in one cookie booth sale or send 24 Digital Cookie messages.
- Attend a Cookie Rally or compete a National Cookie Entrepreneurship Award or Badge. Look up the requirements here: [https://www.girlscouts.org/en/our-program/badges/badge\\_explorer.html](https://www.girlscouts.org/en/our-program/badges/badge_explorer.html).

Girl Scouts will earn a \$300 "Experience Voucher" if they meet the requirements for both programs.

- Helps customers who may not be interested in purchasing product for themselves, but still want to participate in the Sweets & Treats Program.
- Customers may donate in increments of \$7 (each \$7 donation counts as one candy or nut item counting towards rewards).
- GSNENY will distribute nut and candy items to military personnel through Operation Gratitude.
- Girl Scouts simply collect donation, mark card, and submit payment to the Troop Sweets & Treats Manager by the deadline date.
- Girl Scouts who submit 5 or more donations to the Care & Share Program will receive the 2022 Share Patch!
- Care & Share Program not available through Online Nut Store.

## Service Project

October 5 – November 6, 2022

- For the 2022 Sweets & Treats Service Project, we are asking that troops interested in participating collect personal hygiene items to donate to homeless or domestic violence shelters.
- Talk to your Troop Sweets & Treats Manager/Leader about participating!
- Patches will be mailed to the Service Unit Sweets & Treats Manager and distributed with rewards.

## Money/receipt process

- Money is collected when Sweets & Treats are ordered.
- Customers should make checks payable to your Girl Scout's troop.
- Your troop may choose not to accept checks.
- Do not keep large amounts of cash in your possession.
- Make frequent visits to your Troop Sweets & Treats Manager to turn in money.




## Selling tips for Girl Scouts

- **Strategize** - Talk about strategies for optimizing your sales effort with your troop.
- **Familiarize** - Use your order card to familiarize yourself with the products.
- **Important dates** - Discuss the important dates of the Sweets & Treats Program. Write the dates in the box on your order card.
- **List it out** - Make a list of people you think might like to purchase products from you.
- **Practice** - Practice your sales pitch with family or troop members before beginning to sell.
- **Care & Share** - Encourage customers to purchase additional products as gifts or to support your Care & Share project.
- **Thank you** - Always be courteous, smile and say, "Thank you," whether you make a sale or not.

## Safety tips for Girl Scouts

- **Show you're a Girl Scout** - Wear your membership pin, uniform, or Girl Scout t-shirt to clearly identify yourself as a Girl Scout.
- **Use the buddy system** - Always use the buddy system. It's not just safe, it's fun.
- **Be street wise** - Become familiar with the areas and neighborhoods where you will be selling Girl Scout products. Contact your local police department if you're unsure about an area or neighborhood.
- **Partner with adults** - Adults must accompany Girl Scout Daisies, Brownies, and Juniors when they are taking orders, selling, or delivering product. Girl Scouts in grades 6-12 must be supervised by an adult when selling door-to-door and must never sell alone.
- **Plan ahead** - Be prepared for emergencies and always have a plan for safeguarding money.
- **Do not enter** - Never enter the home or vehicle of a person when you are selling or making deliveries.
- **Sell in the daytime** - Sell only during daylight hours, unless accompanied by an adult.
- **Protect privacy** - Girl Scouts' names, home addresses or email addresses should never be given out to customers. Protect customer privacy by not sharing their information except as necessary for the Sweets & Treats Program.
- **Be safe on the road** - Always follow safe pedestrian practices, especially when crossing at intersections or walking along roadways. Be aware of traffic when unloading product and passengers from vehicles.
- **Be net wise** - Girl Scouts must have permission from parents/caregivers to participate in all online activities and must read and agree to the GSUSA Internet Safety Pledge before conducting any online activities.
